APPROVAL OF THE INCREASE IN HONORARIUM FOR BOARD COMMITTEE MEETINGS

Whereas, Article IX Section 15 of the amended PSMBFI by-Laws states that, "the members of the Board of Trustees shall be entitled to reasonable allowances and per diems as may be authorized by the Board";

Whereas, Board Resolution No. 2015 – 33 approved the reorganization of the Board Committees in accordance with the best practices in good corporate governance, wherein the Committees were reduced from seven (7) to five (5) Committees, which results in savings in honorarium fund of the Office of the Corporate Secretary;

Whereas, every committee member receives the amount of P5,000.00 net of tax per committee meeting while the members of the Executive Committee receive P7,500.00 net of tax for regular members and P10,000.00 net of tax for the Executive Committee Chairman and Secretary;

Whereas, the Governance Committee, in the performance of its functions on director compensation, recommended the increase in the honorarium of members of the different Board Committees as follows:
