Apple tops Aramco as most valuable publicly listed company

Apple Inc.'s shares surged over 10 percent to a record high on Friday after reporting blockbuster quarterly results, helping the Uhone maker eclipse Studie Aramco to become the world's most valuable publicly listed companys.

Huawei overtakes Samsung as top smartphone seller

TONDON (AP) - Huawer has over-taken Samsung to become the world's hyg-ged-smartphone seller, as its home market in China emerged from the coronavaria pandemic better off than other economies, according to a technology search firm. Analysts at Canalys said. Thuisday that Huawer shipped 55.8 million devices in the second quarter of 2020. While the figure was down five percent compared with a year ago, it was a smaller decline than rival Samsung, which saw smartphone sales slide 30 percent to \$3.7 million.
