Resolution No. 2022 - 174

APPROVAL OF THE SALAMAT KABALIKAT PROGRAM

Whereas, consistent with the PSMBFI mission to provide timely and quality financial services to public safety practitioners and their families, PSMBFI will launch the Salamat Kabalikat Program as part of the 25th Founding Anniversary celebration of the Association:

Whereas, the aim of the Salamat Kabalikat Program is to give back to the members through a simple cash incentive as gratitude for their loyalty and unwavering support the Association;

Whereas, under the Salamat Kabalikat Program, all members in good standing as of 31 December 2022 will receive Php5,000.00 each;

Whereas, qualified to the Salamat Kabalikat Program are those with Equity Plan Deduction; without past due on their loan amortization; and those who have not been attrited from the service within the cut-off date. New recruits from the uniformed service are also qualified; provided, that their Equity Plan premium deduction has been reflected in their payslips. In addition, members who retired from their respective agencies but opted to continue their PSMBFI membership with updated payments are also qualified;

Whereas, the total amount of Php1.072 Billion is required to support the activity covering a projected 212,326 qualified members as of December 31, 2022 and the mode of payment shall be through the Landbank Payroll Account for PNP and other distribution channels such as checks and Instapay for members from other partner agencies;

Whereas, the Salamat Kabalikat Program shall be funded from the allocated Patronage Refund;

Whereas, Management through the Risk and Audit Committee and the Executive Committee recommended the Salamat Kabalikat Program, which recommendation was approved by the Board;

Now, therefore, be it resolved, as it is hereby resolved, that the Board approves the Salamat Kabalikat Program for all qualified members of PSMBFI;

Be it resolved further, that the amount of Php1.072 Billion to cover the financial incentive and bank charges shall be sourced from the Patronage Refund of PSMBFI;

Be it resolved finally, that copies of this Resolution be furnished the Chairman and the Vice Chairman of the Board of Trustees, the President and the PSMBFI Management for reference and information.
