CREATION OF THE COMMITTEE ON ELECTION FOR THE CY 2023 GENERAL MEMBERSHIP MEETING AND ELECTION AND THE MANNER BY WHICH IT WILL BE CONDUCTED

Whereas, the PSMBFI By-Laws provide that the General Membership shall hold its annual meeting on the third (3rd) Saturday of April of every year. For this year, this falls on 15 April 2023;

Whereas, Article X, Section 20 (Election) of the PSMBFI By-Laws requires the creation of a Committee on Election not later than sixty (60) days before the election to manage and supervise the conduct of election;

Whereas, the Office of the Corporate Secretary through the Executive Committee recommended the creation of the Committee on Election for the General Membership Meeting and Election (GMME) for CY 2023 to be composed of the following:

Whereas, in consideration of the health and safety requirements that are still in place due to COVID, it was also recommended that the GMME be conducted in a hybrid manner or a combination of in-person/face-to-face and virtual attendance;

Whereas, the venue of the GMME for an in-person/face-to-face meeting and where a virtual meeting will be hosted shall be at a venue that can accommodate expected attendees without compromising the minimum safety requirements;

Whereas, during the regular meeting of the Board of Trustees on 31 January 2023, the Board approved the creation of a Committee of Election and to conduct the GMME in a hybrid manner at a venue to be determined by the Management;

Now, therefore be it resolved as it is hereby resolved that the creation of a Committee on Election for the GMME CY2023 with members as specified above is hereby approved;

Be it resolved further, that the GMME CY 2023 shall be held in a hybrid manner or a combination of in-person/face-to-face and virtual attendance to be hosted at a venue which shall be determined by the Management;

Be it resolved further, that copies of this Resolution be furnished to the Chairman and the Vice Chairman of the Board of Trustees, the President, and the PSMBFI Management for reference and information.
